All personnel should be instructed to wear safety glasses and stand well clear of the *Static Table* when in operation.

### **Safety Information**

Throughout this manual, safety information is presented by the use of the terms WARNING, CAUTION, and NOTE. These terms have the following meanings:



## **WARNING**

## **EASTMAN®**

The *Expandable Installation kit* is shipped with all the parts and special tools necessary for proper installation. For ease of installation, familiarize yourself with all parts and assemblies of this kit. Before Installation can take place, it is important that you carefully read and follow the instructions in this manual in the same sequence in which they are presented.

#### **INSTALLATION**

## **⚠** WARNING

Disconnect power source from the M9000 machine before performing this installation. Failure to disconnect power source may cause serious personal injury.

The spreader location may vary by material loading requirments. Loading material on the spreader from the left table end or the right table end. Choose the spreader loading location to meet your needs and proceed with installation as described below.

#### **Track Installation**

The *Expandable Spreader Kit* is shipped with the track sections and all necessary hardware for ease of installation. Open shipping crate and familiarize your self with all the components and assemblies.

Place track sections along table top, end to end on the operator's side table as they will be mounted. Clamp the track in position as shown on the operators side of the table. Make sure the joints in the track are even and DO Not align with seams in table.

Drill 9/32" (.281) clearance holes thru the track, rack plate and table tops. Secure track with hardware provided. Be sure track in mounted firmly to table.




Figure 1 Track Installation




Figure 2 Track Installation (9/32" (.281) clearance holes)

## **Bumper Mount Modification**

The bumper mounts on the spreader docking side must be modified as shown.




Figure 3 Bumper Mount Modification

#### **Stop Cam and Bumper Relocation**

The **M9000** Stop Cam and bumpers must be moved when used with the Expandable Spreader.

The stop cam and burners are to be moved 23" (59cm) from there existing position. Mark the new location on the rack plate. Drill and tap (2)#8-32 holes in the rack plate. Mount the stop cam to the rack plate.

Modify the dust covers as required.

## **Emergeny Stop blocks**

The emergency stop blocks are used to stop the spreader before the end of the track. Mount the stop blocks on the track as shown in figure 1.

## **Expandable Spreader Installation**

The table is now ready for the Expandable Spreader to be installed.




Figure 4 Expandable Installation

Place the spreader on to the table as shown. The track wheel must ride on the track as shown in figure 4. Move the spreader up and down the table to confirm proper track installation and machine operation.

The spreader is now ready for spreading operation.

### **Roll Bar Positioning**

The Roll Bar is supplied with a position shifter and 2 cones. The two cones are used to hold the roll of material on the roll bar. The shifter is used to provide edge control of the material as it is spread on the table. Place the roll bar on the spreader as shown in figure 7.




Figure 6 Expandable Installation




Figure 7 Roll bar Position
